Dennis Birdsall, of Birdsall Farm on Ripley Hill Road, is seeking support from the Town Board for an application to the NYS Dept. of Agriculture and Markets Farmland Protection Implementation Program ("the Program"). Mr. Birdsall has presented his application to Onondaga County Planning Agency, Cortland County and the Town of Scott and has received support/favorable ratings from each.

Councilor Fesko commented the Program does not ensure agricultural use of the land. Mr. Birdsall agreed the Program just restricts development.

Whereas, the Birdsall Farm, located in the Town of Spafford, has applied to Onondaga County to participate in the program through the Onondaga County Agriculture and Farmland Protection Board, and

Whereas, the Birdsall Farm was selected through a competitive selection process by the Onondaga County Agriculture and Farmland Protection Board to apply to the state program, and

Whereas, the Finger Lakes Land Trust has agreed to apply to the state program on behalf of the Birdsall Farm and to hold, monitor and enforce the conservation easement should the project be funded, and

Whereas, the Town of Spafford adopted residential agricultural district zoning where the Birdsall Farm is located with the intent to "retain viable tracts of farmland, preserve agricultural land uses and retain the rural landscape and quality of life related to farming", and

Whereas, the Town of Spafford values the contributions and protection of agriculture in the town and recognizes the important opportunity the NYS Dept. of Agriculture and Markets Farmland Protection Implementation Program provides for farmers across the state,

Now, therefore, on a motion by Councilor Fesko, seconded by Councilor Venezia BE IT RESOLVED, the Town of Spafford does hereby support the application of the Birdsall Farm for the NYS Dept. of Agriculture and Markets Farmland Protection Implementation Program.
