ANNUAL PERMITS ARE REQUIRED

Transfer Station permits are available at the Town Clerk's Office or by mail. The fee is \$30 per year. Send appropriate payment with a self-addressed, stamped envelope to: Spafford Town Clerk, 1984 State Route 174, Skaneateles, NY 13152. No more than two permits will be issued per address. You must have a valid permit to use the Transfer Station. *The month and year indicated on the permit is the expiration date.*

Permits must be visible while at the Transfer Station and are checked throughout the year. The permits are static cling decals and should be placed on the inside of the windshield by the rearview mirror.

RESTRICTIONS:

- > Empty and vent all fuel containers
- > Paint cans must be dry and/or empty
- > **NO ELECTRONICS**
- > **NO YARD WASTE** (this includes branches, leaves, grass clippings, etc)

BLUE BINS

Blue bins are available at the Town Hall during Town Clerk office hours.

RECYCLING GUIDELINES

The Town of Spafford follows OCRRA recycling guidelines.

We currently use a single-stream recycling program. Plastic, glass, metals, paper and cardboard all go in the same container.

Food containers should be emptied of all food and any inner wrappings should be removed. Residue should be rinsed from all containers. **WAXED BOXES ARE NOT RECYCLABLE**, these should be placed in the trash.

Do not leave recyclable items in plastic bags. Empty the contents of the bag into the recycling packer. Plastic bags go in the trash.

NON-RECYCLABLE – TRASH ONLY

- Window glass
- Drinking glasses
- Glass or ceramic dishes
- All ceramic
- All plastic bags
- Petroleum containers
- Waxed boxes/frozen food boxes

METAL DAYS

3rd Saturday of each month April - October

Acceptable items – at least 50% metal:

- > pots and pans
- > coat hangers
- > wire
- > dry, empty paint cans
- > empty and vented fuel containers

Disposal of an item with refrigerant/coolant requires an additional \$10 fee per unit. This fee is to be prepaid to the Town Clerk. The issued sticker must be applied to the unit prior to disposal.

TIRE DAYS

We will accept up to eight (8) tires per Transfer Station Permit. More than eight tires will incur an additional fee at the following rate per tire:

- 15” or less ----- \$2
- 16” and larger ---- \$5
- Tractor tires ----- \$10

This fee is to be prepaid to the Town Clerk. A receipt for the payment will be issued for presentation to the Transfer Station attendant.

CLEAN UP DAYS

You may bring any trash that is too big to fit into the packer; i.e. couches, chairs, rugs, mattresses. **NO METAL ITEMS or TIRES** will be accepted on these days.
